

## **SCHOLARSHIP CRITERIA:**

Our selection is based primarily on financial need, proven ability, grade point average (GPA), community/volunteer service and educational desire. Applicants must be enrolled in at least twelve (12) credit hours to be considered for the HORIZONS Scholarship and at least six (6) hours for the GRAD scholarship. There will be 80 scholarships awarded on the above and below criteria:

- You must be a resident of the state of Colorado
- You must maintain a minimum 2.5 cumulative GPA for first-time college freshmen, a 3.0 Cumulative GPA for continuing students
- CU System applicants are subject to CU GPA requirements
- Scholarship funds to be used for fall and spring semesters. Scholarship funds are not available for summer classes.

## **Required Documents to turn in with application.**

**These documents *must* be turned in or your application will *not* be processed**

### **SAR:**

- 1 copy of your 2010-2011 Student Aid Report: This is the report you receive after Financial Aid has received and processed your information. **Income tax forms will not be accepted**

### **ESSAY**

- After completing this last year of college, what advice would you give to new PHEF Scholars?
- How do you plan on giving back to your community and to PHEF?
- Essay must be a minimum of 500 words.

**CONTRACT AGREEMENT**

By accessing our scholarship funds, you acknowledge that you have read and reviewed the following terms and conditions and that you agree to be bound by them. PHEF/HORISONS reserves the right, in its sole discretion, to change these terms and conditions at any time without prior notice.

Nothing in this agreement shall be construed as guaranteeing that the student will be hired by the hospital upon graduation. Both hospitals reserve the right not to hire a nursing scholarship recipient for whatever reason. However, if I am not offered employment by at the hospital, I shall not be obligated to repay the scholarship.

I agree to the following:

1. After graduation from the Nursing Program (Parkview) or Medical Education Program (St. Mary Corwin) at a college or university approved by the hospital, I will work one year for each two-semester school years my tuition is paid by the chosen hospital. One year of employment is defined as 2,000 paid hours.
2. In the event that only a fraction of the student's tuition is paid by the hospital, then this work obligation may be reduced, following pre-arranged written authorization by the hospital.
3. During the time I am receiving the scholarship, I will maintain at least a 3.0 grade point average. If my GPA drops below 3.0, a decision shall be left to the Scholarship Committee as to whether to continue sponsoring the award.
4. I will begin work at the hospital within sixty (60) days of my graduation, if I am offered employment.
5. If I default in any of the terms or requirements of this contract, the hospital may require, without notice, that the entire principal sum of the scholarship paid on my behalf, together with interest, to at once become due and payable. The scholarship shall bear interest at the rate of twenty (21) percent per annum (for Parkview only).
6. In the event it becomes necessary to place this note in the hands of an attorney for collection, I (student) agree to pay attorney's fees in a reasonable amount.
